STANDARD TERMS AND CONDITIONS

I, the Applicant/Authorised representative of the Applicant (“the applicant”) hereby apply for Credit Facilities in the consideration whereof I bind myself and the applicant to the following conditions which I acknowledge I am fully acquainted with:

1. A Certificate signed by the Accountant and or Director of MIA GAS SUPPLIES (PTY) LTD (“the creditor”), showing the amount owing by the applicant at any one time and reflecting the amount thereupon as due and unpaid shall be sufficient and satisfactory proof of the effects therein stated for the purpose of any action, (whether by way of Provincial Sentence or otherwise) proof of debt on insolvency or for any purpose whatsoever.
2. Notwithstanding the amount which may at any time be owing, the applicant consents in terms of Section 45 of the Magistrate’s Court (Act No. 32 of 1944, as amended) to jurisdiction of the Magistrate’s Court in any action or proceeding otherwise beyond it’s jurisdiction, it being understood however that the creditor shall at all times be entitled to bring any such action or proceeding in the Supreme Court and if any such action be necessary the applicant agrees to pay all costs as between attorney and client including collection commission and tracing charges, if applicable.
3. The creditor shall not be liable for any loss of profit or any damages, direct or indirect, consequential or otherwise, arising from whatsoever cause.
4. The applicant shall give valid notice to his landlord of the terms of these conditions in order to prevent the landlord’s hypothec from being exercised over any cylinders supplied on rental by the creditor.
5. All Air Products gas cylinders, containing the goods, shall remain the property of the creditor. If at any time the applicant shall not have in its possession or control the number of cylinders indicated by the creditor’s records, the creditor may treat the number of cylinders being lost and the applicant shall pay for any such loss by the applicant’s obvious neglect or default. Applicant shall pay the creditor the current replacement cost as specified by the creditor.
6. Payment of rental invoices for cylinders is deemed conclusive (subject to transactions prior to the date of invoice which have not been included in the invoice) as to the applicant’s holding of creditor’s cylinders as shown at the date of the invoice.
7. In the event of non-payment of rental after 3 months, the applicant shall be liable for the full cost of the cylinders and paragraph 5 shall also apply.

8. The applicant undertakes to notify MIA GAS SUPPLIES (PTY) LTD in writing, of any change of address, ownership or liquidation of the applicant's business, within 7 (seven) days of such change. The applicant undertakes to return all cylinders in their possession at time of change of ownership or liquidation to MIA GAS SUPPLIES (PTY) LTD before change is instituted by law otherwise paragraph 5 shall apply. Such notice shall only be effective when MIA GAS SUPPLIES (PTY) LTD have confirmed such notification of changes in writing.

9. Advices, recommendations or opinions by representatives of the creditor, are given and expressed in good faith, and shall not constitute representations of any description, and shall not give rise to any claim against the creditor or such representatives.

10. The applicant hereby chooses domicilium citandi et executandi for all purposes at the address set out in the application for credit facilities above.
