

## Consent with respect to the processing of personal information - Procurement

Growthpoint Management Services Proprietary Limited (“Growthpoint”) would like to acquire freely given, specific, informed and unambiguous consent from you (the “Data Subject”) before it collects any of your personal information from you. In terms of the Protection of Personal Information Act No. 4 of 2013 (“POPIA”), Growthpoint is obliged to provide you with the following information when collecting personal information from you:

- **Responsible party:** Growthpoint Properties.
- **Type of information:** Company name and registration, banking details, B-BBEE information, contact and address information, tax clearance, COIDA and proof of insurance;
- **Nature or category of the information:** Business and compliance-related information, which will be used and stored in South Africa or another jurisdiction which has similar privacy laws or with an entity who has contractually agreed to abide by similar privacy standards;
- **Purpose:** The purpose for which this information is being collected is:
  - To assess whether you/the data subject is capable and able to provide Growthpoint with the required and requested goods and/or services, whichever the case may be, which determination shall be made considering the contractual supply chain and procurement arrangement of Growthpoint with you/the Data Subject, in your capacity as a supplier, contractor, service provider and/or consultant (Supplier);
  - Where declared successful in your/the Data Subject’s appointment as a Supplier with Growthpoint, to attend to any required actions in order to conclude the Procurement Contract with you/the Data Subject including any drafting and/or vetting of the related procurement contractual documents;
  - For purposes of any proposed purchase from you/the Data Subject or any proposed sale to you/the Data Subject;
  - Subject of any goods and/or services for purposes of the procurement contract and in providing any third parties with your/the Data Subject’s Personal Information and/or Special Personal Information in order to evaluate the respective transaction

- and/or due diligence procedure, including conducting the required credit checks, if required; or
- Attending to any required internal operations and procedures in rendering the procurement-related services to you/the Data Subject, in your capacity as a client, or as required for purposes of managing the related procurement contractual relationship, in your capacity as a Supplier, whichever the case may be and this shall relate to any contract management services involved, attending to any financial and payment matters such as budgeting, planning, invoicing, facilitating and making payments, arranging third party payments, sending any receipts, invoices and/or statements and/or generally where required in providing any commercial support and/or communications where needed, requested or required in terms of the related procurement contractual documents.
- **Source:** Information is collected from the Data Subject directly.
  - **Voluntary or mandatory:** The supply of the information is voluntary.
  - **Legal requirement:** Growthpoint is not statutorily obliged to collect personal information.
  - **Contractual requirement:** The [Specify name of agreement if applicable] Agreement entered into with you, the Data Subject makes the supply of the personal information mandatory;

  - **Recipients of information:** Growthpoint will be the recipient of the personal information. We may be required to disclose your personal information to third parties in order to fulfil the terms of the contractual arrangement between ourselves and you, the Data Subject. Such disclosure will only be made where it is necessary to fulfil the purpose for which you disclosed your personal information. Any other disclosure of your personal information will only be made upon your authorisation to Growthpoint to do so, or in the event that Growthpoint is required to do so in terms of POPIA or any other applicable legislation;
  - **Access and right to amend:** You have the right to access your personal information and to request us to rectify the information collected should it be incomplete or contain any errors;
  - **Right to object:** You have the right to object to the processing of your personal information in terms of section 11(3) of POPIA by sending an email to the information officer at [popia@growthpoint.co.za](mailto:popia@growthpoint.co.za); and

- **Complaints:** You have the right to lodge a complaint with:
