Dear Sirs/Madam,

We as Vision Elevators (Pty) Ltd registration number: 2006/010380/07 request to renew our approval ECA1217 to continue making payments to third parties and to accept third party importation documentation.

We have engaged with a supplier, Cilico Microelectronics Ltd, based in China. We noticed they make use of third-party entities for exports to South Africa. The entities we are aware of include Sinotech, Billion Trillion, and Aiwiner Co Ltd, all based in Hong Kong.

As Cilico does not hold its own DHL account. DHL, as the forwarder, utilizes the DHL accounts of these companies for the export process.
